1. Information

About IAAY

It's All About You was established in 2008 by Max Cohen to enable people in Southwest England to find LGBTQ+ affirmative counsellors and other wellbeing practitioners. Since that time, we evolved and proudly announced that we became a Community Interest Company (CIC) on 9th April 2021 called It's All About You Wellbeing CIC (IAAY). This means that we strengthened our commitment to providing support and resources to our beneficiaries in ways that are meaningful to them.

We have three Directors (Max Cohen, Katherine Cox and JC Phillips), alongside a fantastic group of enthusiastic Members who are all passionate about the social benefit that IAAY can make.

IAAY beneficiaries

We're here to support anyone who identifies as being diverse in, or is questioning, their gender identity, sexual orientation or relationship (GSRD), including •Family and friends of LGBTQ+ people

•Professionals who identify as LGBTQ+ or who have an LGBTQ+ family member

•Individual therapy and wellbeing professionals who want to improve their awareness and support to LGBTQ+ clients

•Organisations who want to improve their practice by doing more than just ticking boxes when working with LGBTQ+ communities

What we do

We provide a directory of therapists and wellbeing professionals who have shown a commitment to working affirmatively with LGBTQ+ clients (and our other beneficiaries) so people can contact the right professional for them.

We provide events, courses and groups that are relevant and meaningful, for example:

•Wellbeing courses for trans+ adults (18+)

•Monthly peer support for LGBTQ+ counsellors, wellbeing professionals and trainee counselling students

•Legal webinars

•LGBTQ+ awareness for HR professionals and employers

•Continuing Professional Development (CPD) for therapists and wellbeing professionals

<u>Ethos</u>

- Working in the best interest of the client with an approach which prizes a person's identity as core to a person's being.
- A commitment to opposing conversion therapy for all members of LGBTQ+ communities not seeking to 'change' or 'cure' or 'convert' a person's identity.
- Working to challenge homophobia, biphobia, transphobia, gender stereotyping and inequality of all types that are intersectional to a person's gender, sexual and relationship diversity, for example, faith, race, ethnicity, religion, colour, disability, relationship status and age.

IAAY Members

Directory Members automatically become IAAY Members. The Members Group is made up of Directory professionals, Members who oversee the CIC, volunteers and freelance workers. All are welcome to go Members meetings, help on a stall at Pride events, access training and other events, all of which work to IAAY good practice, ethos, vision mission statements and values.

2. Information about the Directory

The Directory is more than a listing, it involves a commitment to be allies and contribute to the LGBTQ+ communities in the Southwest who are our beneficiaries - LGBTQ+ communities, including family members, partners, friends, carers, other professionals and anyone else who would like to access the services listed.

It provides an opportunity for therapists and wellbeing practitioners to showcase their profiles in order to provide affirming quality services.

The Directory was created so that:

- Clients can easily find safe and inclusive therapists and wellbeing practitioners
- Clients can rest assured they do not need to spend therapeutic time on educating their professional about their gender, sexuality, or other LGBTQ+ issues
- Clients and professionals can draw on a trusted network, so that everyone finds the right kind of help for their changing needs
- Practitioners can choose whether to disclose their own sexual orientation, relationship status and/or gender identity in a professional context

By signing up to be on the Directory all professionals are committing to:

- be adequately trained in the service they are providing
- are members of a Professional body (where there is one for their practice) and adhere to their Professional body regarding policies and best practice
- comply with GDPR, Equality Act, confidentiality and safeguarding children and vulnerable adults
- comply with IAAY policies (diversity and inclusion, social media policy, complaints procedure, code of conduct) found in the current Members' Handbook 2023
- become Members of IAAY alongside other Members who volunteer or work on a freelance basis and oversee the CIC
- work in ways that are intersectional, reflecting culture, race, ethnicity, neurodiversity, disability, faith, spirituality and the spectrum covering the diversity of gender, relationships and sexual orientation
- contribute something each quarter (every three months) to the IAAY network, for example, attend a network meeting, write a blog for the website, share social
 media relating to IAAY events, attend the CIC Members' meetings, host or co-facilitate an event, provide consultation on a particular issue or area of good
 practice, offer administration assistance, introduce other professionals to the network or other support

3. Benefits of being a part of the Directory and Members Group

Comments from the Network Members' survey March 2021

- I benefit from knowing about people who I might be able to refer clients on to if they are looking for support outside my remit.

- Peer support learning from others, being supported by others, being inspired by what others are doing
- Helps raise my profile among LGBTQ+ community
- Referrals for individual and couples counselling
- I feel supported by others in the group. I feel my achievements are celebrated by other group members.
- I find out about training and other issues affecting the LGBTQ+ communities.
- It's great to network with other therapists.
- CPD training experience from others referrals
- Feeling part of a supportive and compassionate group, up to date knowledge about LGBTQ+ law and news as well as it benefits my practice (my work with LGBTQ+ clients) and helps me to be more aware of LGBTQ+ issues.
- Meeting allies in the wellbeing space and learning more about what they do
- Potential clients as a family lawyer would be a benefit
- I have benefitted from being on the directory by gaining new clients who are specifically looking for a counsellor who is compassionate, informed and confident at working with LGBTQ clients. I sense that certain clients know that they won't encounter prejudice in the counselling room if they've chosen a counsellor from the Directory, which means they can be more fully themselves.
- For me as a counsellor, gaining access to a greater diversity of clients brings greater depth and interest to my work, and it's important for me that I demonstrate in this way my openness and acceptance".

5. Application Process

We aim to make the application process as easy and seamless as possible.

Please do not hesitate to get in touch if you have queries or need support to complete any part of the process.

1. Read through IAAYW CIC (IAAY) Directory Information, Application process and Terms and Conditions terms on the Join the Directory page of the website.

2. Complete the Directory Application Form on the Join the Directory page of the website. By submitting their applications professionals are giving consent for IAAY to store their details to comply with GDPR and IAAY privacy policies.

3. Once the application has been submitted it will be processed by one of the IAAY Directors (Max Cohen, Katherine Cox or JC Phillips). The processing stage refers to considering whether the submitted form and documents show the professional is aligned to the IAAY good practice, ethos, vision, mission statement and values and is suitable for the Directory. Directors reserve the right to ask applicants for more information or to inform them that their applications have not been successful and give reasons why.

4. Applicants will be contacted as soon as possible to let them know of the Director's decision. Applicants can apply again at another time and have a right to appeal, if they feel they have not been treated fairly.

5. Successful applicants are required to pay an annual fee to IAAY of £35 for individuals or £70 for organisations.

8. Directory Members will receive an invitation to renew their Directory profile one month before its annual expiry date.
